RHODE ISLAND DUCKPIN BOWLERS HALL OF FAME REQUIREMENTS/QUALIFICATIONS

(Revised 2005)

MERITORIOUS SERVICE: 40 points required for automatic ballot consideration. Any member may be considered for meritorious service. Points are to be used as guidelines.

RIDBA Board of Directors Officer	2 points each
RIDBA Board Member.....	1 point per year
Youth Coach	1 point per year
League Officer (President, Secretary, Treasurer)	1 point total per year
Committee Member (RIDBA BOD, HOF, etc.).....	1 point total per year
National Officer (NDBC)	3 points per year

SUPERIOR PERFORMANCE:

100 Points for ballot, 150 points for automatic induction
20 years as a sanctioned bowler, 10 years minimum in Rhode Island

TOP 20 STATE RANKING LIST:

#1	6 points
#2	5 points
#3 - 5	4 points each
#6 - 14	3 points each
#15 - 20	2 points each

TOP 20 NATIONAL RANKING LIST:

#1	7 points
#2	6 points
#3 - 5	5 points each
#6 - 14	4 points each
#15 - 20	3 points each

Major tournament win (Non Handicap).....	7 points each
Handicap tournament wins.....	4 points each
State record.....	2 points each
New England Record.....	3 points each
World Record.....	5 points each
Pro Tour Top Qualifier	4 points each
Pro Tour Bowler of the Year	7 points each
Tournament Series Finals Winner	7 points each
